### Consultancy Services for Website Development

- 1. The Government of Kenya(GoK) has received financing from the International Fund for Agricultural Development ("the Fund" or "IFAD") towards the cost of Kenya Livestock Commercialization Project(KeLCoP) ("the client") and intends to apply part of the proceeds for the recruitment of consulting services, for which this REOI is issued.
- 2. The use of any IFAD financing shall be subject to IFAD's approval, pursuant to the terms and conditions of the financing agreement, as well as IFAD's rules, policies and procedures. IFAD and its officials, agents and employees shall be held harmless from and against all suits, proceedings, claims, demands, losses and liability of any kind or nature brought by any party in connection with Kenya Livestock Commercialization Project(KeLCoP).
- 3. The client now invites expressions of interest (EOIs) from legally constituted consulting firms (not individual consultants) ("consultants") to provide Consultancy Services for Website Development. More details on these consulting services are provided in the preliminary terms of reference (PTOR) attached as **Annex 1**. The consultant may sub-contract selected activities provided that said services do will not exceed 20% of the total consultancy work.
- 4. Before preparing its EOIs, the consultant is advised to review the preliminary terms of reference attached as **Annex 1**, which describe the assignment and **Annex 2** that details the evaluation of the technical qualifications.
- 5. The consultant shall not have any actual, potential or reasonably perceived conflict of interest. A consultant with an actual, potential or reasonably perceived conflict of interest shall be disqualified unless otherwise explicitly approved by the Fund. A consultant including their respective personnel and affiliates are considered to have a conflict of interest if they a) have a relationship that provides them with undue or

undisclosed information about or influence over the selection process and the execution of the contract, b) participate in more than one EOI under this procurement action, c) have a business or family relationship with a member of the client's board of directors or its personnel, the Fund or its personnel, or any other individual that was, has been or might reasonably be directly or indirectly involved in any part of (i) the preparation of this expression of interest, (ii) the selection process for this procurement, or (iii) execution of the contract. The consultant has an ongoing obligation to disclose any situation of actual, potential or reasonably perceived conflict of interest during preparation of the EOI, the selection process or the contract execution. Failure to properly disclose any of said situations may lead to appropriate actions, including the disqualification of the consultant, the termination of the contract and any other as appropriate under the IFAD Policy on Preventing Fraud and Corruption in its Projects and Operations<sup>2</sup>.

documents audited and/or inspected by auditors and/or investigators appointed by the Fund.

- d. Consultants have the ongoing obligation to disclose in their EOI and later in writing as may become relevant: (i) any administrative sanctions, criminal convictions or temporary suspensions of themselves or any of their key personnel or agents for fraud and corruption, and (ii) any commissions or fees paid or to be paid to agents or other parties in connection with this selection process or the execution of the contract. The evaluation will include a review and verification of qualifications and past performance, including a reference check, prior to the contract award.
- 9. Consultants may associate with other firms to enhance their qualifications but should indicate clearly whether the association is in the form of a joint venture and/or a subconsultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

### **Consulting Services for Website Development**

#### 1. Client

The client for this assignment is Kenya Livestock Commercialization Project(KeLCoP).

#### 2. Country background

The livestock sub-sector plays an important role for Kenya's economy with a direct contribution of around 42 per cent to agricultural GDP and 12 per cent to national GDP. It accounts for 30 per cent of the total marketed agricultural products and provides raw materials for agro-processing and manufacturing. Investment in livestock development, directly contributes to increased income, food and nutrition security of livestock producing households, and by extension their communities. Even in the non-arid and semi-arid land (ASAL) areas, the livestock sub-sector constitutes an important source of family income and food security.

The sub-sector is an ideal enterprise to improve household food and nutrition security, increase incomes, create jobs and contribute to sustainable livelihoods of many rural people living below the poverty line. Small ruminant and poultry sub-sectors are experiencing low productivity and narrow profit margins due to; high cost of feed, poor animal husbandry, poor state of livestock infrastructure and limited availability of processing facilities.

It is in this regard that the Government of Kenya (GoK) requested The International Fund for Agriculture Development (IFAD) to finance a livestock project in the high potential and pastoral counties. IFAD and GoK through the Ministry of Agriculture, Livestock, Fisheries and Cooperatives (MALFC), SDL and participating Counties designed a new project titled the Kenya Livestock Commercialization Project (KeLCoP).

#### 3. Background on project

The livestock sub-sector plays an important role for Kenya's economy with a direct contribution of around 42 per cent to agricultural GDP and 12 per cent to national GDP. It accounts for 30 per cent of the total marketed agricultural products and provides raw materials for agro-processing and manufacturing. Investment in livestock development, directly contributes to increased income, food and nutrition security of livestock producing households, and by extension their communities. Even in the non-arid and semi-arid land (ASAL) areas, the livestock sub-sector constitutes an important source of family income and food security.

It is in this regard that the Government of Kenya (GoK) requested The International Fund for Agriculture Development (IFAD) to finance a livestock project in the high potential and pastoral counties. IFAD and GoK through the Ministry of Agriculture, Livestock, Fisheries and Cooperatives (MALFC) and participating Counties designed a new project titled the Kenya Livestock Commercialization Project (KeLCoP).

Kenya Livestock Commercialization Project (KeLCoP) is a six year project jointly funded by; Government of Kenya (GOK), International Fund for Agricultural Development (IFAD), Heifer International, Participating Financial Institutions (PFI) and Beneficiary communities. The Project Loan negotiation meeting was done on 25-28 August 2020. The IFAD Executive Board approved the Loan in 18 September 2020. The Project came into force on 05 March 2021 with a Completion date of 31 March 2027 and Loan Closing date of 30 September 2027.

The Project Goal is to contribute to the Government's agriculture transformation Agenda of increasing rural small-scale farmers' incomes, food and nutrition security. The development objective is to increase incomes of 110,000 poor livestock and pastoralist households, especially youth and women, in an environmentally friendly manner, in selected project areas of the 10 participating counties. The Project areas are Semi-Arid counties (Elgeyo Marakwet and Baringo), Arid counties (Marsabit and Samburu).and other areas are Busia, Bungoma, Kakamega, Siaya, Nakuru and Trans Nzoia. The targeted value chains are small ruminants (sheep, goats for meat and dairy goats), local improved breed poultry, bee keeping and rabbit production (where applicable).

The primary target group comprises of: very vulnerable, ultra-poor, mostly women headed households, pastoralist and agro-pastoralist households; commercially orientated pastoralist and agro-pastoralist households; and young women and men involved in production and entrepreneurial activity at critical points in the value chain. The project will also engage with value chain drivers KeLCoP will have a strong focus on the inclusion of women and youth, marginalized tribes and persons with disabilities.

The project is expected to directly benefit 110,000 households with a total number of 495,000 people. From the total direct beneficiaries, women and youth beneficiaries will be 54 per cent and 30 per cent respectively. 30 percent of the beneficiaries will be targeted for nutrition interventions. A minimum of 5 per cent of beneficiaries will be from vulnerable groups (marginalized tribes, persons with disabilities and persons with HIV). The beneficiaries of targeted nutrition beneficiaries make up 30 per cent of the total households reached.

The project will be supported by 3 components namely; Component 1: Climate-smart production enhancement for small livestock, Component 2: Support to livestock market development and Component 3: Project management and coordination

The Lead Programme Agency is the State Department for Livestock in the Ministry of Agriculture, Livestock, Fisheries and Cooperatives. The project institutions will be: The Project Steering Committee (PSC), Project Management and Coordination Unit (PMCU), County Programme Coordinating Committees (CPCCs), County Project Technical Teams (CPTTs), Sub-County Technical Teams (SCPTTs) and Ward Committee.

The total project costs of Ksh 9.46 billion (EUR 78.9 million) will be financed by i) an IFAD loan of Ksh 5.53 billion (EUR 46.2) million (ii) a GoK contribution in the amount of Kshs 1.91 billion (EUR 16 million), of which taxes and duties account for Ksh 1.27 billion (EUR 10.6 million), cash Ksh148.34 million (EUR 1.2 million) and in kind contribution in the amount of Kshs 498.34 million (EUR 4.1 million); iii) an Beneficiary contribution of Kshs 1.19 billion (EUR 9.9 million) of which in kind account for Kshs 936.98 million (EUR 7.8 million) and cash in the amount of Kshs 261.69 million (EUR 2.1 million); iv) Heifer International Kshs 342.61 million (EUR 2.8 million) and v) PFIs in the amount of Kshs 460.33 million (EUR 3.8 million).

Component 1 on "Climate Smart Production Enhancement for small Livestock "is the main investment and represents 59.1 per cent of the total project costs, while Component 2 on "Support to livestock Market Development", representing 24.7 per cent of total project costs. 'Project Management and Coordination Unit', represent 16.2 percent of the total project costs (of which subcomponent policy and institutional support to the National Government represents 1.2 per cent and project management and coordination unit support sub component represent 15 percent).

#### 4. Background of the assignment

The project design includes some innovative elements and includes opportunities for the use of a host of digital technologies and applications that deploy Information Communication Technology for Development (ICT4D) approaches and scalable models in partnership with the private sector. The use of innovations and information technology will be integrated into the development of an eextension approach and the development of e-finance to reduce the costs of access and delivery and develop e-marketing systems for information and sale. The project will mainstream climate resilience, and sustainable natural resource management in the smalllivestock, poultry and honey value chain development.

#### 5. Objectives of the assignment

The main objective of this assignment is to design, develop and implement a public-facing website as a custom-made web portal and content management system for KeLCoP. A website that will support integration, with its subsequent APIs and SMS gateway integrations. The interface should be approved and endorsed by KeLCoP. This CMS will also host the database for crowdsourced information which will inform farmers in the project area about the price of their produce in different areas of the country, track prevalence of different livestock diseases, and also help in informing farmers about climatic conditions so that they can better prepare and store animal feeds. The system therefore should provide a platform for interaction and information sharing among all those involved in the project and be an online repository for the projects documentations, reports and other relevant resources.

#### 6. Scope of work

General Requirements:

- A content management system with custom-made functions and features
- Central administration access of all features offered by Application to KeLCoP staff.

- Using CMS tools like Joomla, Wordpress, and Drupal is preferred during the development of this solution to increase speed and interaction of the website.
- Staff Training on CMS, admin backend,
- Full handover of the source code of the website and the Content management system.
- Website design and development on an iterative basis in a process involving the KeLCOP project team so as to accommodate any web concept and design changes.
- Website maintenance, which would include applying security patches, clearing out log files, enlarging disk space before it runs out, sorting out security certificates and fixing bugs in the code.

#### **Functional Requirements:**

- a) Content Management System (CMS): this solution must have a CMS to enable KeLCoP web administrator to easily update the content of the website without the need of programming, this CMS should be able to update content, adding pages, updating home page navigation menu, managing users, uploading media content and any other operations needed to control and update the website without the need to contact the solution provider. Uploading files and media content to the website through CMS must be unlimited and must be stored in a Database, and should be searchable. Creating new pages in the website must enable the website administrator to design the content in that page (paragraphs and images used in the web page) with the minimum knowledge in HTML & JavaScript only. Also adding these new created pages to the main menu should be an easy task through controlling menu nodes. CMS must have the ability to create users and user groups to determine who can do what. All changes made using the CMS by the authorized users must be logged in DB.
- b) The website interface and content will be in English.
- c) The portal is responsive by design.
- d) Search engine: all content of the website must be indexed and searchable and the returning result must highlight the keywords and remove duplicated results, advanced search capability must be available to create a better searching mechanism.
- e) Media gallery: the website should have ready-made tools to create photo gallery or video galley.

#### f) Site Appearance:

- Common Theme and Consistent Design each section of the site should have a common look and feel (designs to be provided by KeLCoP). The use of photographs, colors, fonts and layouts should he consistent throughout the site. Design should be flexible to allow for a large range of monitor sizes while minimizing horizontal scrolling, in addition to the text instead of pictures in case of low bandwidth
- Visually appealing the site must have an attractive mix of text and graphics that does not overwhelm the user.

- Easy to navigate the site should have simple and intuitive navigation that allows users to easily identify where they are within the site and where they need to go.
