

**PEST CONTROL PRODUCTS (LICENCE FEES AND
OTHER CHARGES) REGULATIONS, 2022 S 15(1)**

The Pest Control Products Act is amended by the repeal of Pest Control Products (Licensing fees and other charges) regulations (LN.128 of 2006) and their replacement with the following new regulations:-

**PEST CONTROL PRODUCTS (LICENCE
FEES AND OTHER CHARGES)
REGULATIONS, 2022**

1. These Regulations may be cited as the Pest Control Products (Licence Fees and Other Charges) Regulations, 2022.
2. The fees payable to the Board by any person for services rendered by the Board shall be as prescribed by the Board from time to time as set out in the Schedule and the fees chargeable shall be cumulated in case of combination of businesses in category I in the Schedule.
3. The charges for supervision services rendered by the Board shall be as prescribed by the Board from time to time as set out in the Schedule. For the purposes of this regulation supervision shall include but not limited to disposal and accreditation
4. The Board shall charge a fee of 1.4% free on board (F.O.B.) value of all imports, 50% of which will be paid directly to Agrochemicals Association of Kenya for product stewardship as agreed with the Board.
5. **Inspection upon request to ascertain compliance will be charged according to the category of schedule in addition to mileage charged at AA rates.**
