1. Certificate of Registration/Incorporation
2. Valid Copy of NCA Registration Certificate for Building Works.
3. Valid annual NCA practicing license for Building Works.
4. The Bid Bond must be in form of Bank Guarantee from a reputable bank or an Insurance Company approved by PPRA and must be valid for 150 days
5. Sound financial standing and /or adequate access to bank credit line equal to at least 10% of their Tender Sum.
6. Litigation History of the Company (both court and arbitration cases.)
7. Duly filled, signed and stamped Confidential Business Questionnaire.
8. Duly filled, signed and stamped form of Tender.
9. Duly signed and stamped Statement of compliance.
10. Valid Current Tax Compliance Certificate from Bidding Company, and if Consortium, from each member of the consortium.
