**An Act of Parliament to provide for the development, promotion and regulation of horticulture industry, to provide for the establishment of the Horticultural Crops Authority, to make provision for the respective roles of the national and county governments in horticulture and related matters in furtherance of the relevant provisions of the Fourth Schedule to the Constitution and for connected purposes.**

<b>PART 1 - PRELIMINARY</b>	
Short title	The Act may be cited as The Horticultural Crops Act 2020
Interpretation	<p>1. In this Act, unless the context otherwise requires—</p> <p>“Authority” means the Horticultural Crops Authority established under section 4;</p> <p>“cabinet secretary” means the cabinet secretary for the time being responsible for matters related to Crops;</p> <p>“dealing in horticultural crops” means growing, aggregation, transporting, packing, storage, selling, processing, exporting and importing horticultural produce and products for purposes of trade but does not include dealing for household consumption;</p> <p>“grower” means any person who cultivates horticulture crops in Kenya and includes smallholder farmers and a plantation grower;</p> <p>“inspector” means an officer of the Authority or County government appointed in writing by the Authority or the County Government, to be an inspector, for purposes of this Act and gazetted by the Cabinet Secretary;</p> <p>“aggregation centre” means an area established close to growers for bulking of produce for purposes of collective marketing and enforcement of quality standards;</p> <p>“dealer” means a natural person, a company or a firm engaged in propagation of planting materials, collecting, transporting, storing, buying or selling horticultural produce and includes a ship chandler, an exporter, an importer, processor or a marketing agent;</p> <p>“export” means the selling of horticultural produce to markets outside Kenya;</p> <p>“financial year” means the period of twelve months commencing on the first of July and ending on the thirtieth June of the subsequent year;</p> <p>“horticultural crop” means a crop listed under the First Schedule;</p>

	<p>“import” means to bring into Kenya horticultural produce or products from another country;</p> <p>“levy” means a payment imposed on horticultural produce based on a criterion determined and published in the gazette by the cabinet secretary;</p> <p>“marketing agent” means a natural person, company or firm engaged in buying horticultural produce for sale in the domestic market or export market;</p> <p>“mother block” means an established area for plants known to be free from diseases and true to type that is used as a source of clean rootstocks, grafting and budding propagation materials;</p> <p>“national horticulture standards” means the Kenyan Horticulture Standards formulated and registered by the Kenya Bureau of Standards in consultation with the Authority and the horticulture industry;</p> <p>“nursery” means an area for raising and selling horticulture seedlings including tissue culture laboratories, greenhouses, shed nets and open fields;</p> <p>“Person” includes an individual, firm, a company an association or cooperation which has legal rights and obligations;</p> <p>“postharvest” means all activities involved after harvesting before consumption;</p> <p>“produce” means the harvested part of horticultural crops including roots, tubers, fruits, leafy part, berries or cut flowers ;</p> <p>“produce handling facility” means an area where horticultural produce is assembled for purposes of grading, sorting, packaging or storage;</p> <p>“ship chandler” means a person registered and authorized by the Authority to supply horticultural produce to a ship or an aircraft;</p> <p>“traceability” means the ability to track horticultural produce and process owner from production to the final consumer and vice versa;</p>
Objects and Purpose	<p>1. The objective of this Act is to accelerate the growth and development of horticulture industry, to enhance productivity and incomes of farmers and other value chain actors and in particular;-</p>

	<ul style="list-style-type: none"> <li>a) organize and coordinate the horticulture industry partners and stakeholders;</li> <li>b) Improve and attract investment opportunities and efficiency of agribusiness services;</li> <li>c) facilitate export of horticultural produce and products to augment the foreign exchange earnings of the country; and</li> <li>d) enhance consumer health and awareness by ensuring compliance to produce quality and food safety standards.</li> </ul>
Application	<ol style="list-style-type: none"> <li>2. This Act shall apply to all scheduled crops specified in the First Schedule and to all farms whether privately or communally held as well as to growers, grower organizations, cooperatives and community associations dealing with horticultural crops.</li> <li>3. This Act shall also apply to all horticultural produce and products – <ul style="list-style-type: none"> <li>a) grown, processed or marketed in Kenya; and</li> <li>b) imported to or exported from Kenya.</li> </ul> </li> </ol>
	<b>PART II – ESTABLISHMENT, FUNCTIONS AND POWERS OF THE AUTHORITY</b>
Establishment of the Authority	<ol style="list-style-type: none"> <li>4. There is established an Authority to be known as the Horticultural Crops Authority.</li> <li>5. The Authority shall be a body corporate with perpetual succession and a common seal, and shall in its corporate name, be capable of— <ul style="list-style-type: none"> <li>a) suing and being sued;</li> <li>b) taking, purchasing or otherwise acquiring, holding and disposing of movable and immovable property;</li> <li>c) borrowing and lending money;</li> <li>d) entering into contracts; and</li> <li>e) doing or performing all such other matters or acts necessary for the proper discharge of its functions under this Act, which may be lawfully done or performed by a body corporate.</li> </ul> </li> <li>6. The Authority shall be the successor of the Horticultural Crops Directorate established under AFA Act, 2013 (Rev. 2016) and the Crops Act, 2013</li> </ol>
Functions of the Authority	<ol style="list-style-type: none"> <li>7. The Authority shall perform the following functions in, formulation, implementation and regulation of policies in the horticulture industry;- <ul style="list-style-type: none"> <li>a) advice the Government and the industry on matters related to horticulture development, promotion, imports, exports and food safety standards;</li> <li>b) register dealers of horticulture produce and products;</li> </ul> </li> </ol>

	<ul style="list-style-type: none"> <li>c) Licence exporters, importers and processors of horticultural produce and products;</li> <li>d) Determine research and technology priorities from the industry through collaboration with private sector, public and private research institutions;</li> <li>e) collect and collate data, maintain a database and disseminate information on horticultural industry for development and promotion of the industry;</li> <li>f) represent the country in national, regional and international fora on standards, trade, technology and innovations and any other related matters;</li> <li>g) promote development and adoption of standards for traceability, labeling, packaging, grading, transporting and storing horticultural produce in compliance with local, regional and international standards;</li> <li>h) regulate horticulture crops quality and sanitary standards;</li> <li>i) Advice and promote development of horticulture produce handling, transportation and storage infrastructure to industry and county governments;</li> <li>j) The Authority, in consultation with relevant training institutions and industry stakeholders, may develop a training curriculum and assessment guides for horticulture industry;</li> <li>k) advice the Cabinet Secretary on levies, fees and import or export duties related to horticulture industry; and</li> <li>l) any other matters in furtherance of the development of horticultural crops or conducive to the exercise of any of its powers under this Act.</li> </ul>
Appointment and composition of the Board	<p>8. (1) There shall be a Board of Directors for the Authority consisting of the following members ;—</p> <ul style="list-style-type: none"> <li>a) Chairman appointed by the President;</li> <li>b) the Principal Secretary in the ministry for the time being responsible for Crops development;</li> <li>c) the Principal Secretary in the ministry for the time being responsible for finance;</li> <li>d) the Principal Secretary in the ministry for the time being responsible for Trade;</li> <li>e) a representative from the Council of Governors in responsible for agriculture;</li> </ul>

	<p>f) the Chief executive Officer who shall be an ex-officio member of the Board with no voting rights;</p> <p>g) Four members appointed by the Cabinet Secretary for the time being responsible for Crop development; one member representing;—</p> <ul style="list-style-type: none"> <li>i. Registered flowers, fruit and vegetables growers association under this Act;</li> <li>ii. Registered nursery operators association under this Act;</li> <li>iii. Registered exporters' association under this Act; and</li> <li>iv. Registered association of horticulture marketing agents under this Act.</li> </ul> <p>(2) A person appointed as a members of the Board under Sub-section 8 (1) shall;</p> <ul style="list-style-type: none"> <li>(i) be a citizen of Kenya;</li> <li>(ii) Meets the requirements of leadership and integrity outlined in Chapter 6 of the Constitution;</li> <li>(iii) Holds a Degree from a University recognized in Kenya; and</li> <li>(iv) Has knowledge and experience either agriculture, finance, law, administration, human resource management or such other expertise as the appointing authority may consider relevant.</li> </ul> <p>(3) The members appointed under subsection 8(g) shall serve for a three year term, but may be eligible for reappointment for a second term.</p> <p>(4) The Cabinet Secretary shall publish in the Gazette the Names of the appointed Board members within a period of sixty (60) days after the enactment of this Act.</p>
Cessation of membership of Board	<p>9. A member of the Board other than the Chief Executive Officer, shall cease to be a member if the member;—</p> <ul style="list-style-type: none"> <li>a) resigns from office in writing to the Cabinet Secretary;</li> <li>b) is absent from three consecutive meetings without permission of the Chairperson of the Board;</li> <li>c) is adjudged bankrupt;</li> <li>d) is incapacitated by prolonged physical or mental illness or otherwise unable or unfit to discharge the functions of the office;</li> <li>e) ceases to represent the interest in respect of which he was appointed to the Board;</li> </ul>

	<p>f) contravenes the provisions of Chapter 6 of the Kenya Constitution 2010; and</p> <p>g) is convicted of a criminal offense</p>
Replacement of Board member	<p>10. (1) If the office of a member of the Board becomes vacant, the Board shall notify the Cabinet Secretary.</p> <p>(2) The Cabinet Secretary upon notification shall initiate the process of replacement as per section 8 within a period of sixty days.</p>
Powers of the Board of Directors	<p>11. (1) The Authority shall be governed by a Board of Directors appointed in section 8</p> <p>(2) The Board of Directors shall have all the powers necessary for the proper performance of its oversight functions over the Authority and the exercise of its responsibilities as provided in this Act, the State Corporations Act or any other applicable law, and without limiting the generality of the foregoing, has power to—</p> <p>a) control, supervise and administer the assets of the Authority in such manner as best promotes the purposes for which the Authority is established;</p> <p>b) determine the provisions to be made for capital and recurrent expenditures and for the reserves of the Authority;</p> <p>c) receive any grants, gifts, donations or endowments and make legitimate disbursements from the amounts received;</p> <p>d) approve opening of such banking accounts for its funds as may be necessary;</p> <p>e) invest any of its funds not immediately required for its purposes in any manner authorized under this Act;</p> <p>f) enter into association with such other bodies or organizations within or outside Kenya as it may consider desirable or appropriate in furtherance of the purposes for which the Authority is established;</p> <p>g) Appointment of staff for the Authority</p> <p>h) co-opt in those committees persons whose knowledge and experience are necessary to enable the committee to effectively discharge its functions.</p> <p>i) appoint agents for the implementation or performance of any function of the Authority under this Act;</p>

	<ul style="list-style-type: none"> <li>j) control, supervise and administer the assets of the Authority in such manner and for such purposes as best promotes the purpose for which the Authority was established;</li> <li>k) lay down policy guidelines for the operations and management of all the funds collected by the Authority;</li> <li>l) undertake any other activity necessary for the fulfilment of the Authority's functions.</li> </ul>
Committees of the Board	<p>12. (1) The Board may, for the effective discharge of its functions, establish committees or abolish any such committee as it may deem necessary.</p> <p>(2) A committee established under this section consists of such persons as the Board from time to time appoints.</p> <p>(3) The Board may co-opt into the membership of a committee any person whose knowledge and skills are considered necessary for the effective discharge of the functions of the Authority.</p> <p>(4) Any person co-opted into a committee may attend the meetings of the committee and participate in its deliberations, but has no right to vote at the meetings.</p> <p>(5) The Board may direct the committee established under this the manner in which the committee will conduct its functions in relation to meetings of the committee, including the procedure to be followed; -</p> <ul style="list-style-type: none"> <li>a. in convening meetings of the committee;</li> <li>b. the number of members of the committee to constitute a quorum;</li> <li>c. the appointment of a member of the committee to preside at meetings of the committee;</li> <li>d. the manner in which questions arising at a meeting of the committee are to be addressed;</li> <li>e. the voting rights of members of the committee; and,</li> <li>f. the disclosure of members' interests in matters being considered by the committee.</li> </ul>
Conduct of business of the Board	<p>13. (1) The conduct and regulation of the business and affairs of the board shall be in accordance with the second schedule.</p> <p>(2) Except as provided in the schedule, the Board may regulate its own procedures.</p>

The Chief Executive Officer	<p>14. (1) There shall be a Chief Executive Officer of the Authority, who shall be competitively recruited and appointed by the Board on such terms and conditions as the Board may determine.</p> <p>(2) the Chief Executive Officer shall be responsible for:</p> <ul style="list-style-type: none"> <li>a) day to day administration of the affairs and transactions of the Authority;</li> <li>b) Conveying decisions of the Board and implementing policies of the Authority; and</li> <li>c) The exercise, discharge of objectives, functions and duties of the Authority.</li> </ul> <p>(3) The Chief Executive Officer may hold office for a period of not more than 3 years renewable once.</p>
Qualifications of the Chief Executive Officer	<p>15. A person shall qualify to be appointed to the position of a Chief Executive Officer if such person; -</p> <ul style="list-style-type: none"> <li>(a) holds a relevant degree and post graduate qualification from a university recognized in Kenya;</li> <li>(b) has at least ten years' knowledge and experience in a relevant field;</li> <li>(c) Has demonstrated leadership abilities;</li> <li>(d) has at least 5 years' experience in a position of senior management; and</li> <li>(e) meets the requirements of Chapter Six of the Constitution.</li> </ul>
Corporation Secretary	<p>16. (1) There shall be a Corporation Secretary who shall be the secretary to the Board.</p> <p>(2) The terms and conditions of service of the corporation secretary shall be determined by the Board.</p>
Remuneration of the Board and members of staff	<p>17. The Authority shall pay to its staff and board members, such remuneration, fees or allowances as determined by the Salaries and Remuneration Commission.</p>
Personal liability of Board members	<p>18. (1) No member of the Board shall be personally liable for any act or default of the Authority done or omitted to be done in good faith and without negligence in the course of the operations of the Authority.</p> <p>(2) Provided that in the conduct of the affairs of the Authority, members of the Board shall; -</p>

	<ul style="list-style-type: none"> <li>a. exercise due prudence and diligence in discharge of their function; and</li> <li>b. be held jointly and severally responsible for any losses incurred due to any act done by them and which is contrary to this Act.</li> </ul>
Personal liability of staff	19. Staff of the Authority shall not be held personally liable to any action, claim or demand for a matter or thing done bona fide for the purpose of executing the functions, powers or duties of the Authority.
Liability of the Authority for damages	20. Section 19 shall not relieve the Authority of the liability to pay compensation to any person for any injury to him, his property or to any of his interests caused by the exercise of any power conferred by this Act or by the failure, whether wholly or partially, of any works.
<b>PART III - ROLE OF COUNTY GOVERNMENTS</b>	
Role of county governments	<p>21. (1) Pursuant to the Fourth schedule of the Constitution, the County Governments will implement the national government policies to the extent that the policies relate to the county and in particular shall be responsible for-</p> <ul style="list-style-type: none"> <li>(a) Establishment of fora for coordination of horticulture development partners and service providers;</li> <li>(b) mapping and alignment of all horticulture projects and programs to existing government policies;</li> <li>(c) Regulate and enforce national standards related to horticulture production, handling, marketing and food safety for local trade;</li> <li>(d) collect and collate production and marketing statistics for planning and sharing with the Authority;</li> <li>(e) Capacity build stakeholders including horticultural growers, grower associations and private sector players on matters related to horticulture; and</li> <li>(f) Facilitate establishment of infrastructure for horticulture markets, aggregation centres, transportation, processing and storage facilities.</li> </ul> <p>(2) In execution of the roles provided for in sub-section (1), the county governments may establish a Horticulture Technical Working Group to provide for technical guidance in Horticulture matters in the county.</p>

No person shall process, import or export horticultural produce and products without a valid licence issued by the Authority or County government.</p> <p>24. Licenses issued under this Act shall remain in force effective first of July until the thirtieth of June of the following year, unless earlier cancelled.</p> <p>25. A person who contravenes any provision of this Section commits an offence and shall upon conviction be liable to imprisonment for term not exceeding three years or to a fine not exceeding two million shillings or to both.</p>
<p>Application for Licence renewal</p>	<p>26.(1) An application for the renewal of a licence shall be made to the Authority or respective county government not later than the first day of the month of March in which the current licence is due to expire:</p> <p>(2) A late application may be made provided that a late application fee of ten per cent (10%) of the prescribed</p>

Licensing provisions	<p>27. The Authority or county government shall not issue a licence under this Act unless the Applicant has met the requirements prescribed in the Regulations under this Act</p>
	<b>PART V: REGISTRATION PROVISIONS</b>
Registration of dealers by the Authority and County government	<p>28.(1) A dealer shall not conduct any horticulture business unless that person is registered by the Authority or County government in accordance with this Act.</p> <p>(2) The Authority shall register the following;</p> <ul style="list-style-type: none"> <li>(a) Horticulture produce marketing agents supplying produce for the export market;</li> <li>(b) Shipchandlers supplying produce to sea and air vessels;</li> <li>(c) Clearing and forwarding agents handling horticultural produce;</li> <li>(d) nursery operators and mother block operators for the export market;</li> <li>(e) horticultural packing facilities for the export market; and</li> <li>(f) horticulture associations.</li> </ul> <p>(3) The county government shall register the following;</p> <ul style="list-style-type: none"> <li>(a) Horticulture produce marketing agents supplying produce for the domestic market;</li> <li>(b) nursery operators/mother block operators (planting material propagators) supplying planting material to the domestic market; and</li> <li>(c) horticultural packing facilities supplying produce to the domestic market.</li> </ul> <p>(4) The Authority shall issue a certificate of registration to applicants in section 29(2).</p> <p>(5) The respective County government shall issue a certificate of registration to applicants in section 29(3).</p> <p>(6) The Cabinet Secretary may, in consultation with the Authority, prescribe regulations for registration of dealers.</p>

Registration of growers	<p>29.(1) Every grower shall be registered by the respective county government where their farm is located for purposes of—</p> <ol style="list-style-type: none"> <li>continuous data capture and updating;</li> <li>planning production and marketing, inputs estimates and financial services; and</li> <li>quality assurance and traceability.</li> </ol> <p>(2) The Cabinet Secretary may, in consultation with the Authority and County government, prescribe regulations for registration of growers.</p>
