5.	The Shape of the tanks, would the Ministry allow round shape of tanks in addition to elliptic as mentioned in the TDS?	Round shape tanks will be allowed to compliance with other specifications particularly the evaporator being at least up to 1/3 rd height of the tank.
6.	What is the required power rating for each PV Panel? We can see both 545W and 570W mentioned in the tender?	Solar panel rating is 545W instead of 570W as per the bills of quantities and specifications.
7.	Energy storage system ,we are concerned that the specified low voltage batteries are not sufficient ,would the Ministry consider the change to high voltage instead	The Specified batteries voltage and capacity appropriately determined and are adequate. Bidders are advised to stick to the specifications.
8.	Instruction to Tenderers: 4.5 A firm that is a Tenderer (either individually or as a JV member) shall not participate as a Tenderer or as JV member in more than one Tender except for permitted alternative Tenders. Such participation shall result in the disqualification of all Tenders in which the firm is involved. However, this does not limit the participation of a Tenderer as subcontractor in another Tender or of a firm as a subcontractor in more than one Tender.
