

ADDENDUM No.1 : Clarifications on the Request for Bids Non-Consulting Services for procurement of Business Accelerator for Digitally Enabled Agripreneur Model No. KE- MOALF-455542-NC-RFB:

In response to the clarifications sought, the employer wishes to clarify on the issues raised as follows: -

1	<p>Page 79: 7. Participating Counties & Sub-Counties:</p> <p>Is the project coverage 32 or 34 counties as the list shows only 32 counties and few sub counties;</p> <p>is the project coverage only these 168 sub counties or more are expected to be added in due course. If yes, by when?</p>	NAVCDP project is implemented in 34 counties. However, the Agripreneurs model will be rolled out in 33 counties as indicated in table 1 below. Tana River county with 5 sub-counties is the only county missing in the table in page 79.
2	Can you please confirm the number of Agripreneurs targeted? Is it 5,375 or 7,000	The model is targeting 7,525 Agripreneurs across 33 counties. Every ward will have 7 Agripreneurs at the bootcamp and incubation stages.
3	Are the Agripreneurs expected to provide extension services? Would the Ward Agriculture officers (WAOs) play any role in supporting the Agripreneurs?	Part of the Agripreneurs responsibility is to provide extension services to farmers in collaboration with the county extension team. In doing this the Ward Agriculture officers (WAOs) together with other sub-county technical teams (SCTT) will supervise, mentor and guide the Agripreneurs.
4	<p>Page 69: Section 1.3. Project Target and Coverage</p> <p>Can you please share the county wise mapping of the Value Chains?</p>	Table 2 below provide the county mapping of NAVCDP priority value chain.
5	Page 72: Section 3: Activity Schedule: Are the TIMPs for all the nine value chains developed in video & text format? If yes, in what format will they be shared with BA?	NAVCDP project has prioritize 16 value chains across the 33 counties. All the TIMPs will be provided by KALRO in both text and video format.
6	<p>Page 77: Technical Support Structure says "Deploy mentors in each implementing ward"</p> <p>Page 72: Activity schedule says "deploy business coaches and mentors at the county (sub-county) level";</p> <p>Please confirm if the mentors are to be deployed at the ward level or the sub county level.</p>	The Agripreneurs Mentors will be deployed at the sub-county levels. Every sub-county will have one mentor/coach.

7	<p>Page 77: Activity schedule says, "establish linkages with ecosystem value chain actors such as SACCOs, FPOs & Agtechs"</p> <p>Are there other parallel initiatives like business acceleration for SACCOs, FPOs etc., if yes, what is the overlap and how is the co-relation envisaged; what is the scope of work in this engagement to establish linkages?</p>	<p>There are already initiatives to register SACCOs, FPOs, input/output service providers and onboarding of Agtechs, all this data and information will reside in the same Agricultural big data where the Agripreneurs model will be operating from. Linking this data and the Agripreneurs platform will be happening at the big data.</p>
8	What are the languages for the Digital AP training modules?	All the digital training modules /materials should be in English with a corresponding alternative version in Swahili.
9	What is the expected frequency and duration of mentorship sessions for agripreneurs?	The mentorship for the Agripreneurs will be happening for the first 12months. For the first 3 months, the mentorship will be happening on monthly basis and for the next 9 months will be happening on a quarterly basis.

What is the role of BA in this engagement?</p>	NAVCDP project will onboard the service provider, Agtechs and value chain actors. This information will reside within the big data. The BA is expected to onboard all the providers into the catalogue, mapping out the service/product offered, cost of the service/ product and presence in terms of geographical coverage either at county, sub county or ward level. All this to be linked to Agripreneurs digital application.

13	<p>Ecosystem Trainings: Does the program already have a list of the ecosystem actors / service providers?</p> <p>Is the role of the BA only to develop a calendar of national and county-level events, such as workshops, seminars, and training sessions, to sensitize, onboard, and engage service providers or to conduct the same; Does the BA have to budget for these trainings? If so, would that be done at a county level, or a sub county or ward level and at what frequency?</p>	<p>NAVCDP project will onboard the service provider, Agtechs and value chain actors. The BA is expected to come up with a routine calendar as per the training and coaching schedules. The training will be done at county levels where the BA is expected to cater for the cost of the trainers and any other associated cost to the BA during the training and sensitization sessions.</p>
14	<p>"Page 113: Amendments of, and Supplements to, Clauses in the General Conditions of Contract"</p> <p>Different timelines exist for different deliverables, so does that mean all deliverables would be bulked up for payments? What are the placement constraints as indicated in the RFQ?</p> <p>What is the Minimum no. of Agripreneurs per Sub county or County that can be committed for resource costing & planning?</p> <p>Assuming there are multiple cohorts, how would payment terms be spread out across cohorts?</p>	<p>The payment schedule will be as stipulated in the bid document.</p> <p>There will be a minimum of seven Agripreneurs per ward and the roll out will be once per county, meaning there will be only one cohort per county.</p>
