The State Department for Livestock Development invites interested bidders for a Public Auction as follows;

Auction for: **Unserviceable Motor Vehicles, Farm Machinery, Trees, Laboratory Items and assorted Equipment.**

Location: **D.V.S Kabete (Upper Kabete Road) and National Beekeeping Institute -Lenana (Ngong Road)**

CONDITIONS OF SALE

1. Interested bidders are advised to view the Motor vehicles, Farm Machinery, Trees, Laboratory items and assorted equipment's to verify their condition at the State Department for Livestock Development various stations across the Country indicated on the schedule list, the appointed Auctioneer or the State Department does not give warranty of the items earmarked for disposal.
2. Interested bidders can obtain the list containing details of all items earmarked for disposal from the Head of Supply Chain Management Unit and are at Liberty to access the location of the items to make their own assessment.
3. All the interested bidders will be required to pay a **10% deposit** of the Reserve Price as indicated per **item or lot** prior to participating in the Auction. The deposit shall be payable (i) in cash at **the State Department for Livestock Development - Cash Office (Kilimo House)**, or (ii) vide Bankers cheque addressed to the **Principal Secretary State Department for Livestock Development**. An **Official Receipt Must be issued** for all payments. This amount is refundable to unsuccessful bidders. Interested bidders who provide proof of Auction Deposit shall be given **Auction Bidding Numbers that shall be issued against the official receipt presented.**
4. The Successful bidders shall be required to pay **25% Cash, deposit to the State Department for Livestock Development - Cash Office (Kilimo House, or a Bankers Cheque** payable to the **Principal Secretary State Department for Livestock Development** of the purchase price at the fall of the hammer (*the 10% deposit forms part of this sum*) and present the payment details as may be appropriate. The balance shall be paid within **fourteen (14) working days** after the auction. A period of fourteen (14) days from the date of the Public Auction shall also be the allowed to the Successful Bidder to take possession and remove the items upon Full Payment and Official release by the Accounting Officer from **Premises of Locations Indicated.**
5. Where the successful bidder fails to make payment of the auction items within the specified period, the bidder shall **forfeit the 10% Bid Deposit** and the Motor Vehicle, Farm Machinery, Trees, Laboratory items or equipment's shall be offered to the **Second Highest Bidder.**

6. The Sale is subject to the reserve price and other requisite contents
7. The appointed Auctioneer Reserves the right to accept or reject any bid without giving any reason whatsoever.
8. Transfer of Ownership documents to the successful bidders shall be as per the Government guideline.
